USE OF DISTRICT FACILITIES and EQUIPMENT BY STAFF

POLICY

The Board will permit staff to use school district facilities and equipment, except vehicles, provided the

- does not conflict with School District or community use; a)
- b) is occasional and personal, not commercial;
- does not consume materials and supplies without reimbursement; c)
- d) has no adverse effect on the condition of the facilities and/or equipment;
- does not threaten the security of buildings or the safekeeping of equipment; e)
- does not interfere with the regular work hours or job performance; f)
- is of facilities and equipment which the staff member is competent to operate and has completed g) a written waiver of liability;
- receives the prior approval of the individual responsible for the administration of the facility. h)
